AN ORDINANCE TO PROVIDE A TITLE FOR THE ORDINANCE; TO DEFINE WORDS; TO PROHIBIT MARIHUANA FACILITIES AND MARIHUANA ESTABLISHMENTS WITHIN THE BOUNDARIES OF DEWITT TOWNSHIP PURSUANT TO MEDICAL MARIHUANA FACILITIES LICENSING ACT, PUBLIC ACT 281 OF 2016, MCL 333.27101, *ET SEQ.*, AS MAY BE AMENDED, AND INITIATED LAW 1 OF 2018, MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT, MCL 333.27951, *ET SEQ.*, AS MAY BE AMENDED; TO PROVIDE PENALTIES FOR VIOLATION OF THIS ORDINANCE; TO PROVIDE FOR SEVERABILITY; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; AND TO PROVIDE AN EFFECTIVE DATE.
