**PREAMBLE**

AN ORDINANCE TO AMEND CHAPTER 30 OF THE TOWNSHIP'S CODE OF ORDINANCES BY PROHIBITING THE DISCHARGE OF A FIREARM IN TOWNSHIP PARKS UNLESS IN COMPLIANCE WITH STATE LAW; TO REPEAL ORDINANCES IN CONFLICT HEREWITH; AND TO ESTABLISH AN EFFECTIVE DATE HEREOF.

The DeWitt Charter Township is amending Chapter 30, Section 22 of the Township's Code of Ordinances to reflect a default to state law on the regulation of firearm possession.

Second Reading and opportunity for comment before the Township Board on Ordinance 2019-04-06 shall be at 7:00 PM, on Monday, April 22, 2019, at the DeWitt Charter Township Hall, 1401 W. Herbison Road, DeWitt, MI 48820.
