AN ORDINANCE TO ADOPT THE INTERNATIONAL PROPERTY MAINTENANCE CODE, 2015 EDITION (INCLUDING APPENDIX A), PUBLISHED BY THE INTERNATIONAL CODE COUNCIL AS THE PROPERTY MAINTENANCE CODE FOR THE CHARTER TOWNSHIP OF DEWITT REGULATING AND PROVIDING MINIMUM STANDARDS WHICH SHALL APPLY TO EXISTING RESIDENTIAL AND NON RESIDENTIAL STRUCTURES AND ALL EXISTING PREMISES, STRUCTURES, EQUIPMENT AND FACILITIES FOR LIGHT, VENTILATION, SPACE, HEATING, SANITATION, PROTECTION FROM ELEMENTS , LIFE SAFETY, FIRE SAFETY AND OTHER HAZARDS, AND FOR SAFE AND SANITARY MAINTENANCE THEREOF; AND TO AMEND PROVISIONS THEREOF WITH REGARD TO RELATED CODE REFERENCES, TO ADD AND/OR REVISE DEFINITIONS AND PROVISIONS FOR APPOINTMENT OF THE OFFICIAL AND ESTABLISHMENT OF FEES, PROVISIONS FOR WEED CONTROL, INSPECTION; AND FOR ADMINISTRATION, ENFORCEMENT AND PENALTIES FOR VIOLATION OF SAID PROVISIONS; REPEAL ORDINANCES AND PORTIONS OF ORDINANCES INCONSISTENT WITH THIS ORDINANCE; AND TO ESTABLISH AN EFFECTIVE DATE HEREOF.

Second Reading and opportunity for comment before the Township Board on Ordinance 2017-03-01 shall be at 7:00 pm, on Monday, April 10, 2017, at the DeWitt Charter Township Hall, 1401 W. Herbison Road, DeWitt, MI 48820.
