

## **NOTICE OF ORDINANCE ADOPTION/OPPORTUNITY FOR PUBLIC INPUT**

Please take notice that the DeWitt Charter Township Board has, on 4-23-18, approved on First Reading, Zoning Ordinance Amendment 42.11 which does in effect, constitute a step in the process of adopting a new Zoning Ordinance, as follows:

#### **ORDINANCE 42.11**

#### **ZONING ORDINANCE AMENDMENT (TEXT AND MAP)**

**AN ORDINANCE TO UPDATE, AMEND AND RE-FORMAT CHAPTER 42, "ZONING" OF THE DEWITT CHARTER TOWNSHIP CODE OF ORDINANCES AND RELATED ZONING MAP FOR PURPOSES OF INCORPORATING CLEARZONING FORMATTING AND CLARIFYING AND AMENDING CERTAIN PROVISIONS.**

**THE DEWITT CHARTER TOWNSHIP ORDAINS:**

#### **Section 1. Ordinance Amendment**

Chapter 42, "Zoning," of the DeWitt Charter Township Code of Ordinances, including the zoning map, as initially adopted on August 8<sup>th</sup>, 1977, and subsequently amended, is hereby amended in its entirety to read as revised and comprehensively reformatted in the DeWitt Charter Township zoning ordinance and map that are attached to, part of, and adopted by this Ordinance.

#### **Section 2. Repealer**

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect, and the DeWitt Charter Township Ordinance Code shall remain in full force and effect, amended only as specified above.

#### **Section 3. Severability**

If any section, clause or provision of this Ordinance shall be declared to be unconstitutional, void, illegal or ineffective by any Court of competent jurisdiction, such section, clause or provision declared to be unconstitutional, void or illegal shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force and effect.

#### **Section 4. Savings**

All proceedings pending and all rights and liabilities existing, acquired, or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law in force when they were commenced.

**Section 5 Effective Date**

The provisions of this Ordinance are hereby ordered to take effect on the date provided by applicable law.

**Notice is further given that Second Reading and opportunity for comment before the Township Board on Ordinance Amendment 42.11 will be on Monday, May 28, 2018, at 7:00 p.m. at the DeWitt Charter Township Hall, 1401 W. Herbison Road, DeWitt, MI 48820. Written comments will be made part of the written record, if received by 12 o'clock noon on May 28, 2018.**
