

**DeWITT CHARTER TOWNSHIP

NOTICE OF PUBLIC HEARNG**

The DeWitt Charter Township Planning Commission will conduct a Public Hearing on Monday, June 5, 2017 beginning at 7:00 p.m., at the DeWitt Charter Township Hall, 1401 W. Herbison Road, DeWitt, Michigan 48820. The purpose of the hearing is to afford an opportunity for the public to comment on request for Special Use Permit 17-990001 from John and Donna Makara.

The subject of the Public Hearing will be the consideration of a request from John and Donna Makara for Special Use Permit 17-990001 (Major Amendment to SUP 70-004-91 and SUP 04-990001) to be allowed to expand the area of existing Special Use Permits for outdoor storage of firewood, logs, landscape materials and equipment on an approximately 2.930 acre vacant property located on the east side of S. US 27, south of Wieland Road, north of Granger Meadows Lane in the northwest ¼ of Section 34 of DeWitt Charter Township (Parcel #050-034-200-055-00).

The subject site is legally described as follows:

A parcel of land in the Northwest ¼ of Section 34, T5N, R2W, DeWitt Township, Clinton County, Michigan, the surveyed boundary of said parcel described as: Commencing at the Northwest corner of said Section 34; thence South 00 degrees 59'23" East along the West line of said Section 34, a distance of 1449.89 feet to the point of beginning of this description; thence North 89 degrees 15' 40" East 250.00 feet; thence North 00 degrees 59'23" West parallel with said West line 130.00 feet to the North line of the North ½ of the South ½ of said Northwest ¼; thence North 89 degrees 15'40" East along said North line 200.00 feet; thence South 00 degrees 59'23" East parallel with said West line 355.92 feet; thence South

89 degrees 15'28" West 450.00 feet to said West line; thence North 00 degrees 59'23" West along said West line 225.95 feet to the point of beginning. Also known at Property Address: V/L S. US 27, Lansing, MI 48906. Parcel ID No. 050-034-200-055-00.
