WHEREAS the DeWitt Charter Township Board of Trustees and Planning Commission have engaged in the review of the existing Comprehensive Development Plan and amendments thereto, in accordance with the procedures described in Public Act 168 of 1959, as amended (commonly known as the Township Planning Act); and

WHEREAS the DeWitt Charter Township Planning Commission has reviewed the existing Comprehensive Development plan and proposed a series of amendments; and

WHEREAS the public has provided input on the development of the Plan at the Public Hearing held on September 4, 2012; and

WHEREAS the Board of Trustees and Planning Commission have cooperatively reviewed the draft amendments and provided comments that have been incorporated into the Plan; and

WHEREAS the Board of Trustees has duly reviewed the Comprehensive Development Plan amendments and accepts it as the basic plan for the development of the Township pursuant to the authority of the Township Planning Act; and

WHEREAS the Planning Commission held a public hearing on September 4, 2012, in accordance with the requirements of the Township Planning Act, to receive comments on the Comprehensive Development Plan; and

WHEREAS the Planning Commission acted after the public hearing to adopt the Comprehensive Development Plan amendments that resulted from public comments, planning commission, and governing body reviews over the last twelve months;

NOW THEREFORE be it RESOLVED that:

1. The DeWitt Charter Township Comprehensive Development Plan amendments, as described in the minutes of the October 1, 2012 Planning Commission meeting, shall be and are hereby adopted; and
2. This Resolution shall be published inside the back cover of each copy of the DeWitt Township Comprehensive Plan to certify that all maps, charts and descriptive and explanatory matter therein are a part of the Plan.


