The regular meeting of the DeWitt Charter Township Public Safety Committee was called to order by Chair Steve Musselman at 6:05 p.m. with the Pledge of Allegiance.

AGENDA **Seeger moved to approve the agenda as presented. Reed seconded the motion. The motion was approved unanimously on a voice vote.**

Public relations plan for police and fire departments — The scope of the PR plan was defined as three-pronged: public safety, Municipal Building South and the 2026 millage.

Bylaws change — Steve Lennartz was introduced as a former Township firefighter who is interested in contributing to the committee. His role is yet undefined. The search for an additional committee member or members continues; until the search is completed, a move to amend the bylaws to allow additional committee members remains tabled.

NEW BUSINESS Municipal Building South — The committee heard what Chief DeKorte and Chief Gute liked and didn't like about Meridian Township's newest fire station following their tour of the facility.
