### NEW BUSINESS

1. Committee Appointment – Doug Burke

The Township Board has appointed Mr. Burke to the Public Safety Committee. Mr. Burke gave a brief summary of his background and experience, which should prove valuable to the Committee, and the Departments the Committee interacts with.

2. National Night Out – name change

The Township will no longer use the name National Night Out, for various reasons, and will call the event DeWitt Township Public Safety Block Party

3. DeWitt Township Public Safety Block Party – Township Contribution

The event committee has requested the Township approve up to \$3,000 for the event. It is hoped that sponsorship will be sufficient that the full amount will not be expended.

4. HOA Contact List

It was determined that the HOA Contact List is no longer necessary, with enrollment in RAVE Alert/Smart 911.

5. Set next meeting

The next meeting of the Public Safety Committee will be at 2 p.m. on Tuesday, September 20, 2022. Meeting attendees will have the option of attending live at the Township Hall, or via Zoom. The meeting will include the Public Safety Block Party committee members.

## PUBLIC AND STAFF COMMENTS

Interim Chief Jones provided a Police Department update:

- The Township Board has hired Matt Merony as the new Police Chief; he will start on Monday, August 22.
- Filling open positions continues to be challenging.
- Call volume remains busy.
- Officer Stump is expect to return to work in approximately two months.

Chief DeKorte provided a Fire Department update:

- A request has been make to adjust the budget, to accommodate the different types of calls the department responds to.
- Rotunda Trailer Park is officially closed.
- The department responded to a fatal house fire on Brook Rd.
