

#### **AMERICAN RESCUE PLAN ACT**

American Rescue Plan Act (ARPA) funds were allocated in federal legislation in 2021, and the Township anticipates receiving our portion of ARPA funds (\$1,633,667) by the end of 2022. The funds are required to be obligated by 2024 and spent by 2026. These payments are received in two equal installments: one received in October 2021 and the second is anticipated to be received during the first quarter of 2022. These funds can be utilized to support public health response, replace public sector revenue loss, fund water and sewer infrastructure, address negative economic impacts, premium pay for essential workers and broadband infrastructure. At this time, the Township Board has not taken any action on these funds. Discussions will likely take place in 2022 once the second payment has been received and guidance on the use of these funds has been finalized. Currently, staff is researching and compiling data on potential uses and legislation compliance.

#### **2022 BUDGET**

The 2022 Budget process is finishing up with adoption anticipated November 8, 2021. Our process is very deliberate and thorough, starting in July with format,



strategic plan and other relevant data distributed to Township Department Heads. From the beginning in July, many conversations take place inevitably discussing "needs" and "wants" with what we believe to be best for our services and best for our residents. The budget was prepared in accordance with the Michigan Uniform Accounting and Budget Act as well as the Charter Township Act

of Michigan. The budget is balanced, meaning revenues plus appropriated fund balances equal or exceed expenditures.

All funds have positive fund balances. The total budget for all funds is approximately \$10,200,000 with a general fund balance projected at 25.4%. To view the entire 2022 Budget, visit <a href="www.dewitttownship.org">www.dewitttownship.org</a>.

#### DO NOT DRINK AND DRIVE FOR THE HOLIDAYS



The MADD (Mothers Against Drunk Driving) Tie One On For Safety Holiday Campaign kicks off the festive season by reminding us that drinking and driving don't mix. Some of the most dangerous days of the year on our nation's roadways are between Thanksgiving and New Year's Day. So, from November 1st to December 31st, the MADD Tie One On For Safety Holiday Campaign urges you to designate a sober driver and to hand over your keys. It's more important to get home late and alive, than to risk driving drunk or even buzzed. Keep your holiday celebrations enjoyable by preventing tragedy. When you have a designated driver, you are more likely to get home safely to the ones you love. Every year, hundreds of families receive a knock at the door informing them a loved one was taken from them due to a senseless decision made under the influence of alcohol. The decision is 100 percent preventable.

In addition, a new study by the National Highway Traffic Safety Administration (NHTSA) shows an alarming increase in the presence of alcohol and other drugs among traffic crash victims during the COVID-19 pandemic. From March 17, 2020 to July 18, 2020, 64.7% of drivers tested positive for at least one active drug (including alcohol), compared to 50.8% from Sept. 10, 2019, to March 16, 2020. Alcohol presence was found in 28.3% of drivers involved in crashes, up from 21.8% before the pandemic. Other drugs are also a concern: 32.7% of drivers tested positive for active THC, and opioid presence among drivers almost doubled from 7.5% to 13.9%. There were 1,083 fatal traffic crashes during 2020 and the percentage of alcohol-involved fatalities in Michigan increased by 11% from 295 deaths in 2019 to 326 deaths in 2020. This represents 30% of all traffic fatalities for the year.

The DeWitt Township Police Department wants to remind residents to stay safe this upcoming holiday season. We want everyone to have fun and enjoy the holidays; however, if you are planning on drinking, assign a designated driver to get you home safely. Today, there are many options available such as Uber and Lyft, taxis and public transportation. There is no excuse to drive while impaired by alcohol or other drugs. Have a safe and enjoyable holiday season!

#### CEMETERY FALL AND WINTER ADORNMENT

Fall is a lovely time to visit the Township's cemeteries. The mature trees are dressed in their fall colors, and fall plantings add to the beauty of the grounds. Additionally, our staff works conscientiously to carefully maintain Gunnisonville and Hurd Cemeteries for our residents.

If you wish to plant at the grave site of your loved one, you may do so within the 12 inches surrounding the grave monument or marker. Perhaps mums or tidy grasses are your choosing. Mulch (only) can also be added within that 12 inches. Your grave blankets and other winter decorations will need to be placed after November 15<sup>th</sup> and removed by March 15<sup>th</sup>. Permanent vases, such as those made entirely of cement, may also be used for your plantings. You are required to place your cement vase within the 12 inches of the monument or marker, making sure that the base is flush with the ground. #### **HOME VALUES**

As the leaves change and the weather turns cooler, the Assessing Office starts to transition towards year-end calculations of property assessments for the 2022 tax year. Each year, property values are analyzed to determine if our assessed values are keeping up with changes in the overall real estate market. Since the COVID-19 pandemic started in early 2020, we saw a brief drop in housing sales, followed by strong sales and increasing prices. As we determine the appropriate home values for the upcoming year, we must consider these sales. We make an independent appraisal of each property; however, we must also factor in changes in the real estate market. We look at the preceding 24 months of sales to determine trends, and then apply them to individual properties, to arrive at your assessed value for the upcoming year. Our tentative valuations are mailed to each property owner in February, contained in your assessment notice.

### **ESTIMATING TAXES FOR A NEW HOME/ADDITION/CHANGE**

The property tax system in Michigan is very complex, and there are not many "rules of thumb" that can be followed when estimating taxes. It will always be safer to contact the Assessing Office if you are looking for an estimate of how a new home purchase, an addition to your property, or some other change in a property will affect the taxes. The Assessing Office is the best place to go when looking for an estimate of taxes for a new home, which can change dramatically when compared to the taxes of a previous owner. It is common to see taxes double for a new owner, when compared to the taxes of a prior owner when the property comes "uncapped." #### DO YOU KNOW WHAT CONSTITUTES AN ILLEGAL BURN?

There has been a recent uptick in the number of illegal burns within the Township. Do you know what constitutes an illegal burn? Consequences of an illegal burn range from a verbal warning to a Municipal Civil Infraction with a fine. Open burning guidelines and restrictions are listed below:

DeWitt Township residents are allowed to open burn from October 1<sup>st</sup> through April 30<sup>th</sup>. Residents in the R-6 neighborhoods of the Pines, Northway Hills, and Shadybrook are **NOT** allowed to open burn at any time. The burning shall only be what nature has dropped from trees or grown on the ground.

- Open burning must be done between the hours of sunrise and sunset.
- ➤ The open burning of natural debris shall be done at a safe distance from all buildings, trees, tall grass, and other combustibles.
- $\triangleright$  Burn piles can be **no** larger than 5' x 5' x 3'.
- > The fire **shall** be constantly attended to until the fire is extinguished.
- Burning can only take place when the wind velocity is below 10 MPH.
- Recreational fires are allowed year-round, as well as in the R-6 neighborhoods. Recreational fires shall be extinguished by 2:00 a.m.
- Any fire that will be offensive or objectionable due to smoke or odor emissions, when atmospheric conditions or local circumstances make such fires hazardous, shall be prohibited.

All open burning requires a burning permit issued through the DeWitt Township Fire Department. The burning permit application is located on the DeWitt Charter Township website under the "How Do I..." page or using this link, https://www.dewitttownship.org/181/Burning-Permits.

#### **HELP REDUCE CONSTRUCTION WASTE**

According to the EPA, U.S. construction waste from construction and demolition has increased from 170,000 million tons annually in 2005 to 600,000 million tons in 2018. This waste consists of concrete, wood, gypsum, steel, brick/block, roofing material and asphalt. It comes from projects including: new construction, renovation and demolition of residential and commercial buildings, roads and bridges. So how can the building industry, contractors, do-it-yourselfers and project designers turn this ship around?

- During excavation, stockpile and reuse excavated materials.
- Collect shipping boxes, wood scraps, metal and other construction waste to recycle or sell for salvage.
- Buy, sell or donate used construction supplies. Check stores and websites for everything from insulation, windows and doors, to tiles, appliances and more.
- When installing new carpets, choose those made from recycled materials and recycle your old carpets.
- Take used batteries, fluorescent bulbs, unwanted chemicals and paints to recycling or hazardous waste collection facilities.
- Include an on-site space for recyclable construction materials.
- Find building contractors and project partners who are like-minded regarding limiting construction waste for your project.

One new and upcoming way of reducing construction waste is offsite construction, also known as prefabrication, which is gaining popularity among contractors. It has been shown to reduce construction waste, increase sustainability, decrease build time, make efficient use of existing labor, and improve schedule accuracy and cost estimates. This process results in very little unusable waste.

#### **TAX NEWS**

Winter property taxes will be levied and mailed on December 1<sup>st</sup>, and are due on Monday, February 14, 2022. Drain, streetlight, and other special assessments are included on the winter bill.

Tax payments are collected at DeWitt Charter Township through February 28, 2022. Thereafter, outstanding tax balances are turned over to the Clinton County Treasurer for collection. Once taxes are turned over to the County, payments on the outstanding balance must be paid to the County Treasurer, as State statute prohibits collecting taxes at the Township after February 28<sup>th</sup>.

We understand sometimes things happen, and offer these suggestions to minimize the consequences and extra expense when taxes can't be paid on time:

- Partial payments are accepted. Paying down the balance will reduce interest charges along the way.
- Pay taxes before sewer services. It is to the property owner's advantage to settle the tax bill first to avoid setting the tax foreclosure process in motion. Outstanding sewer services ultimately become a lien on the property and are turned over to taxes at a later date.

#### **Group Utility Billings**

The Township offers a group billing option to help streamline the payment process for property owners managing more than five properties or locations in the Township. If you would like to receive a group billing versus multiple post cards, please reach out to the Treasurer's Office at 517-668-1411 to set it up.

#### **Leaving Town?**

Snowbirds and residents temporarily relocating for the winter months can contact the Treasurer's Office to update billing addresses for sewer accounts. While away, the Treasurer's Office offer these convenient options:

- Enroll in paperless e-billing
- Enroll in ACH Sewer Autopay
- Pre-pay your account for a quarter, or two
- Note township tax and utility billing dates and due dates on your calendar

#### **SNOW REMOVAL**

In the fall of 2015, the Complete the Streets Ordinance (O2015-1-7) became effective. A provision for snow removal was provided in the Ordinance to ensure safe passage for walkways including sidewalks and shared use pathways within the Township. Instead of requiring all sidewalks and pathways within the Township to be cleared of snow, the adopted ordinance ensured that "sidewalks to nowhere" did not need to be cleared. Below are some relevant guidelines as to when sidewalks are to be cleared of snow or ice:

- Sidewalks and shared use pathways shall be cleared from a path of at least 36" in width from the outside edge.
- Snow and ice shall be removed from sidewalks or shared use pathways within 24 hours after accumulation or drifting of snow, sleet or freezing rain or by the beginning of business hours the next day, whichever is shorter to ensure passage.
  - o Exception provided when the wind chill is below zero degrees Fahrenheit
- In the event of a significant snow or ice event, an additional 48 hours shall be allowed for the removal of snow and ice from sidewalks or shared use pathways.
  - Significant snow/ice event means a period of snowfall of 6 inches or greater within a 24-hour period or ice formation of greater than ¼ of an inch.

Please review the snow removal maps posted on the Township's website to see if you fall within a snow removal jurisdiction. These maps can be found on the Planning Department page, under maps or <a href="https://www.dewitttownship.org/193/Planning-Department">https://www.dewitttownship.org/193/Planning-Department</a>. Some of the following subdivisions and locations that are included in the ordinance:

Arbor Meadows; Creekside; Creeping Brook; Crowner Farms; Hawthorne Woods, East, and Village; Heritage Glen, Meadows, and Woods; Northway Hills; Oakland Hills; Ridge Rock; Saffron Hills; Shadybrook; Sherbrook; Springbrook Hills, and East; Windy Ridge; along Old U.S. 27; and recently constructed sidewalks along Herbison Road and Airport Road.

#### **ASSESSING OFFICE REMINDERS**

<u>LAND DIVISIONS, COMBINATIONS OR LOT LINE ADJUSTMENTS</u>: Residents often inquire as to the process for creating a new parcel from their existing land, or combining parcels that they own that lie adjacent to each other, or adjusting the boundary lines of two parcels that are commonly owned and adjacent. The first step in this process is to contact the Assessing Office at 517-669-6494. We can go over any potential issues with the proposed adjustments, and begin the application process.

<u>VETERAN EXEMPTIONS</u>: Veterans Affairs will be sending letters to veterans summarizing their benefits. A copy of this form is needed by the Assessing Office in order to process any disabled veteran exemptions that will be submitted for the following year. The Assessing Office will mail prior applicants information regarding how to apply for 2022.

<u>DECEMBER BOARD OF REVIEW</u>: The final meeting of the Board of Review for 2021 will take place in mid-December. Please contact the Assessing Office with any issues such as a disabled veteran exemption application or a hardship application, as this is the final meeting when these items can be addressed for 2021.

#### **UPCOMING EVENTS**

#### SPECIAL RECYCLING & WASTE COLLECTION

The Clinton County Department of Waste Management provides special recycling and waste collection events each year. The health and safety of our residents, vendors, volunteers and employees is our priority and we will be following CDC and State guidelines.

#### **Medication Disposal Programs**

Protect your family, pets, the community and the environment by properly disposing of unwanted or expired medications through one of the drop off programs noted below. Do not put medications "down the drain" or in the trash. They can end up in surface waters and negatively impact local ecosystems. The preferred disposal option is through designated drop off sites which ensure safe disposal through incineration. *Please keep your medications in their original containers. Be sure to black out any personal information.* 

Pills, tablets, and capsules can be safely and securely dropped off at the Clinton County Sheriff's Office lobby, Bath Township Police Department and DeWitt Charter Township Hall, Monday through Friday, 8:00 am to 5:00 pm. More locations can be found online at <a href="https://www.clinton-county.org/679/Waste-Wizard">www.clinton-county.org/679/Waste-Wizard</a> and <a href="https://www.takebackmeds.org">www.takebackmeds.org</a>. These sites do not accept needles, inhalers, aerosols or patches. Please do not deposit these items into the container. It is dangerous for those emptying the disposal box.

Please be sure to black out personal information; however, leave the drug name visible!

#### **SORTING IS IMPORTANT AT DROP OFF RECYCLING SITES**

The Clinton County Department of Waste Management would like to remind residents to take the time to properly sort their recyclables into the proper containers located at the Township Hall. In order to keep this collection site available to our residents, please make sure you leave only those items that are accepted, sort what you bring into the various pails, and do not bring corroded batteries (as it contaminates the whole pail). Please do not ignore the signs that are posted.

Help keep the cost of recycling down and make sure what is put into the bin can be recycled. #### WHAT'S OPEN IN THE PARK SYSTEM FOR WINTER?

With the cold weather comes the closure of restrooms (weather depending – November  $15^{th}$  – May  $1^{st}$ ) and parks. Here is what's happening:

- > Granger Meadows East Park restrooms will be closed for the winter. The parking lot will also be closed.
- ➤ Granger Meadows West Park (sledding hill) restrooms will be open. The warming room will open when there is enough snow to sled down the hill. Sledding is allowed on designated slopes only.
- ➤ Valley Farms Park all restrooms will be closed for the winter.
- Padgett Park all restrooms will be closed for the winter.
- ➤ DeWitt Dog Park is closed December 1<sup>st</sup> through April 1<sup>st</sup> to maintain the integrity of the turf.
- Paved trail system will remain open.

All parks are open from sunrise until sunset with the following exceptions:

- 1. The paved trail system at Valley Farms Park and Granger Meadows Park is open 24 hours per day year round. From sunset to sunrise, the paved trails are limited to walkers and joggers only.
- 2. From November 1<sup>st</sup> until March 31<sup>st</sup>, the sledding hill at Granger Meadows Park is open from sunrise until 10:00 p.m. From April 1<sup>st</sup> until October 31<sup>st</sup>, the sledding hill is open from sunrise until 11:00 p.m.
- 3. From November 1<sup>st</sup> until March 31<sup>st</sup>, cross country skiing is allowed at Valley Farms Park, Granger Meadows Park and the Richard A. Padgett Natural Area from sunrise until 10:00 p.m.

Dogs and other household pets are allowed in the Richard A. Padgett Natural Area and the Granger Meadows Park natural wood chip trail area **only**. Pets must be on a leash of not more than six (6) feet and be under the control of a competent and physically adequate person at all times. Pet waste must be immediately removed and disposed of in an appropriate manner. No pet shall be allowed in any public building or restroom.

#### **EVERYONE LIVES IN A WATERSHED**



No matter where you live, you live in a watershed. A watershed is the land area that drains to a single body of water such as a lake or river. Watersheds come in many different sizes. A few acres might drain into a small stream or wetland, or a few rivers might drain into a large lake. The actions of people who live in a watershed affect the health of the waters that run through it. Rainfall and snowmelt wash chemicals, fertilizers, sediment, and other pollutants from the land into water bodies. To achieve healthy watersheds, we need your help!

The greater Lansing area falls within the Grand River Watershed, where water eventually drains into Lake Michigan. The urbanized area around the City of Lansing lies within a portion of the Upper Grand River Watershed which can be broken into three smaller

watershed areas. If you live in the area, you live in the Grand River Watershed, the Looking Glass River Watershed, or the Red Cedar River Watershed.

Rivers and streams do not recognize political boundaries. It is important that the public and local governments work together to protect our water resources for current and future generations. Twenty of the communities that fall within our local watersheds are participating in the Greater Lansing Regional Committee for Stormwater Management (GLRC), a cooperative effort that seeks to address water quality in our lakes, rivers, streams, and wetlands. You can help protect our water by following the *top ten things we can do to protect our watersheds*:

- 1. Always conserve and reuse water wisely.
- 2. Soil test before you apply fertilizers. Use low or no-phosphorus fertilizers.
- 3. Use native vegetation and reduce turf grass by increasing native wildflowers and grasses.
- 4. Capture and reuse rainwater to control stormwater runoff.
- 5. Dispose of pet waste properly in the trash or toilet (not onsite septic systems).
- 6. Wash your car on the lawn instead of pavement (if allowed by local ordinance).
- 7. Maintain all vehicles, eliminating leaks and spills.
- 8. Recycle and dispose of household chemicals properly (motor oil, household cleaners, paint, etc.)
- 9. Inspect and maintain onsite septic systems and sewers.
- 10. Participate in the GLRC or join a local watershed organization



Having a clean environment is of primary importance for our health and economy. Clean waterways provide recreation, commercial opportunities, fish habitat, and add beauty to our landscape. All of us benefit from clean water - and all of us have a role in getting and keeping our lakes, rivers, wetlands, and groundwater clean. #### **NEWS BITES**

**BURNING PERMITS** - You can obtain a burning permit on-line. All open burning requires a burning permit issued through the DeWitt Township Fire Department. **COMMITTEE & COMMISSION APPLICATIONS** – Have you ever thought of serving the community in a more "official" way? Often, your friends and neighbors have been instrumental in shaping our community into what it is today. Contact the Clerk's Office for a Committee and Commission application. Applications are kept on file for use as vacancies occur.

**SEWER BACKUP – WHO TO CALL** - The Southern Clinton County Municipal Utilities Authority (SCCMUA) operates and maintains the sanitary sewer system of DeWitt Charter Township. If you have a sewer backup, <u>immediately</u> notify SCCMUA at 517-669-8311 or call 911 Emergency Dispatch after hours. SCCMUA will respond for itself and the Township. If a problem within the sewer system is found, SCCMUA will be the agency responsible for determining cause, coordinating claims, and keeping customers informed.

**MERCURY HEALTH THERMOMETER EXCHANGE** – The Clinton County Dept. of Waste Management (DWM) accepts old mercury health thermometers year round at their office located at 1307 E. Townsend Road, Suite 102 in St. Johns (MMDHD Building). Residents are encouraged to transport their old mercury thermometers in a plastic Ziploc baggie. The DWM will exchange your old mercury health thermometer for a new digital thermometer. You can also drop off your mercury thermometers at the Township Hall Clerk's Office and exchange it for a digital one. **Limit one digital thermometer per person.** 

**PUBLICATIONS** - DeWitt Charter Township publishes legal notices in the DeWitt-Bath Review. Occasionally, when a weekly publication is not sufficient to meet the requirements of the law, the Lansing State Journal is utilized for a publication. Legal notices, such as a Notice of Public Hearing, can also be found on the Township's website, www.dewitttownship.org.

**ACCOUNTABILITY AND TRANSPARENCY** - In an effort to increase transparency and accountability, the Township has created a number of systems and documents that are designed to visually review the status of our government. It is intended to help the user quickly evaluate key indicators. Over time, it helps citizens, business owners, staff, and elected officials measure and monitor the overall health and direction of our local government.
